This contract represents the complete terms and conditions between _____ (“client”) and Yasmine/Magic Hips.

1. Yasmine / Magic Hips shall provide:

b) The event performance/show type shall be: (please check all that apply to performance request)

- Yasmine Solo Show Performance for one set for the duration of up to 20 minutes (standard) = \$225
- Magic Hips Dancer Solo Performance for one set for the duration of up to 20 minutes (standard) = \$165
- Duet Performance for one set for the duration of up to 25 minutes (standard) = \$275
- Trio Performance for one set for duration of up to 25 minutes (standard) = \$375
- Additional sets (per each additional set)

- b) Standard performance is appropriate for all ages/family friendly and shall include entrance with veil, finger cymbals, dynamic drum solo and if appropriate may end with encouraging audience participation through getting the bridal party and any guests up & dancing but the performer(s) will not force those who are uninterested in participating.
- c) The performers shall arrive @15-30 minutes prior to set performance time & shall provide music in the form of a burned CD or may possibly provide set music on iPod.
- d) Bridal party may request any special song(s) to include in the performance & send to me no less than 3 weeks prior to the performance and when "possible" dancer(s) can try to coordinate costume colors to bridal party.
- e) Although it is important for dancer(s) to start performance at agreed upon time, we always allow some extra time for weddings (up to a 30 minute delay) as we schedule our events because we know that uncontrollable events can affect your schedule and is included in set price.

c) The client shall provide:

- a) Non-refundable Deposit in the amount of **\$50.00 for soloist and \$75 for duets/trios** is due immediately to secure performer(s) for event date & time unless other payment methods/terms have been arranged per Yasmine’s discretion. Cash or check payable to **Yasmine & Magic Hips** Or Credit Card payment over the phone: AMEX, MC, VISA (\$25 Returned Check Fee policy enforced)
- b) The Balance for performance in the amount of \$ _____ is due immediately following the performance. Cash preferred or Check payable directly to contracted performer’s legal name if other than Yasmine/duet or trio performance)*If the performance is canceled less than 7 days prior to the event, payment in full is still required. Balance Payment may also be paid by credit card over the phone up to 5 days prior to the event as an option.
- c) A safe and adequate space for the performer(s) shall be provided. This includes a floor or stage space that is free of broken glass, spilled liquids, or other hazardous objects. This also includes an environment that is free of harassment of a sexual nature or otherwise. If the performers deem the environment unsafe for the above reasons, they may stop the performance and client will still be responsible for paying the full amount.
- d) A sound system with CD playing capabilities or iPod hook-up capabilities shall be provided by the client, preferably in the same room/area in which the performance is to take place. The sound system is an important part of the show. Louder is better!
- e) The client shall communicate cultural background of the guests & any special suggestions or requests prior to the performance. The performance has been carefully choreographed and it is difficult to make changes once the performance has begun.
- f) Often the performers will have more than one engagement per night, so it is important that the show start at the agreed upon time. In some cases, lateness in excess of the 30 minute included delay time may result in a shorter show and/or breach in contract and an extra charge of \$50 may apply. Please pay the performer(s) in a timely manner once services have been rendered. If the performers are required to wait more than 15 minutes after the show for payment, an extra charge of \$25 will apply. Please help us to get out the door on time so that we can remain on schedule.
